

## Terms and Conditions

### Options Trading Promotion – Equities Accounts

Colmex Pro Ltd (hereinafter **“the Company”** or **“Colmex Pro”**) is a financial services company incorporated and registered under the laws of the Republic of Cyprus, with registration no. 260064. Its registered office is located at 117 Makariou III Avenue & Sissifou Street, Quarter of Apostoloi Petrou & Pavlou, 3021 Limassol, Cyprus. The Company is licensed by the Cyprus Securities and Exchange Commission (hereinafter **“CySEC”**), under license no. 123/10 to provide investment services through its electronic trading platform.

#### **A. The Promotion**

New clients who open an equities’ trading account with the Company, under which options trading is available, and make a qualifying deposit of a minimum \$1,000 (hereinafter **“qualifying deposit”**) and existing clients holding an equities’ trading account may trade options commission-free. Participation in this Promotion (hereinafter **“the Promotion”**) and eligibility for the free trading commissions are subject to the Terms and Conditions outlined herein (hereinafter **“Terms”**).

**1. Eligibility:** This Promotion is available to: (i) new clients who open an equities’ trading account with the Company, make a qualifying deposit as indicated in Section 3 below, and qualify for options trading; and (ii) existing clients who hold an equities’ trading account and qualify for options trading.

**2. Promotion Period:** The Promotion begins on 1<sup>st</sup> April 2026 (**“Start Date”**) and will remain valid until 1<sup>st</sup> June 2026 (**“End Date”**), unless terminated earlier by the Company.

#### **3. Qualifying Deposit Requirements:**

3.1 New clients that will open an equities’ trading account with the Company and make a qualifying deposit of **\$1,000** will be entitled to trade in options commission-free until the 1<sup>st</sup> of June 2026.

3.2 Eligible existing clients who hold, an equities’ trading account with the Company will be eligible to trade in options commission-free until the 1<sup>st</sup> of June 2026.

##### **Example:**

New Clients: If a deposit is approved on the 18<sup>th</sup> of May 2026, the client will be able to trade options commission-free until the 1<sup>st</sup> of June 2026 (inclusive).

Existing Clients: If an existing client is eligible for the Promotion, they will be able to trade in options commission-free from the date of participation until 1<sup>st</sup> of June 2026 (inclusive).

#### **4. Important Information:**

4.1 To qualify for options trading, clients must first open and maintain an equities’ trading account, subject to the requirements outlined in Section 5. Once approved

for equities trading, clients may apply for options trading through their client area. Approval for options trading is subject to the Company's assessments, as set out in Section 5.

- 4.2 Eligibility for the Promotion is restricted to clients recorded in the Company's systems at the time of account creation as having been referred by Daniel and Shlomi Yazamot Ltd – "Daniel Damari", unless the Company decides otherwise in its sole and absolute discretion.
- 4.3 For clarification purposes, "commission-free" shall mean that the standard options trading commission charged per contract under the applicable pricing tier shall be waived. The Company's tiered plans trading commissions for options trading is outlined on the [Contract Specifications for Options](#).
- 4.4 For new clients, the trading commission applicable to the client's trading account will be calculated based on the client's trading plan as of the day and amount of qualifying deposit. Existing clients are not required to make an additional deposit and will remain subject to their current trading plan.
- 4.5 The Company reserves the right, at its sole discretion, to refuse the granting of any Promotion benefit if it has reasonable grounds to believe that a client has engaged in abusive behaviour or misuse of the Promotion aimed at obtaining the Promotion benefit.

**5. Account Registration:** Opening a Colmex Pro trading account is subject to the Company's registration process and internal procedures, which may include passing the Company's appropriateness assessment, being within the Company's positive target market, and obtaining final approval by the Company.

**6. Acceptance of Terms:** Only clients who accept the present Terms will be eligible to participate in the Promotion.

**7. Non-Changeable Commission Plan:** During the Promotion period, clients cannot change their trading commission plans.

**8. One-Time Benefit:** Please note that this is a onetime Promotion and clients are not allowed to benefit twice from the promotion, by making a second eligible deposit, unless the Company, at its sole discretion, specifically approves clients to be benefitted twice from the promotion.
